The Scholarship Committee of the CLEARs Inland Chapter funds scholarships to assist its members in attending the annual training and technology seminar. This year the seminar will be held from November 14-18, 2016 at the Peppermill Resort, in Reno Nevada.

All scholarship recipients will be required to write and submit an article on the highlights of their conference experience to the Inland Chapter CPR (California Police Recorder Magazine) representative. This article is due to the chapter President no later than November 25, 2016. Recipients of full scholarships may be asked to share hotel accommodations with other recipients.

In order to qualify for a full or partial scholarship, the following requirements must be met:

- The Scholarship Application must be received by **Monday, August 15, 2016**. Applications received after this date will not be accepted.
- You must be a paid member of the CLEARs Inland Chapter in good standing.
- You must have a minimum of one year Record Supervisor experience or equivalent, i.e. Records Lead or Shift Supervisor. The attached form must be filled out completely or it will be returned.

In addition, the Scholarship Committee will also consider the following factors:

- Are you an active participant in the Inland Chapter? For example, are you a Board member, serve on a committee or hosted a monthly meeting?
